*** Starting from 1 March 2017 until 31 August 2017, Thailand will implement a temporary tourist visa fee exemption scheme and a temporary Visa on Arrival (VOA) fee reduction scheme, which will apply for nationals of **Andorra, Bulgaria, Bhutan, China including Taiwan, Cyprus, Ethiopia, Fiji, India, Kazakhstan, Latvia, Lithuania, Maldives, Malta, Mauritius, Papua New Guinea, Romania, San Marino, Saudi Arabia, Ukraine and Uzbekistan**, who hold passports/travel documents of the countries/territory of their nationalities. Nationals of the said countries/territory will be entitled to be exempted from visa fee when applying for Tourist Visa (single entry) to Thailand during the aforementioned period.
